



PRIVACY POLICY

This Privacy Policy applies to information collected through www.CGSPhysician.Services (to be hereby known as the Site). Carefully read this Privacy Policy in its entirety.

You are automatically accepting and agreeing to the most recent version of this Privacy Policy, as well as CGS Physician Services, LLC's Terms and Conditions, whenever you create, register with or log into an account on or through the Site. Similarly, you are automatically accepting and agreeing to the most recent version of this Privacy Policy, as well as CGS Physician Services, LLC's Terms and Conditions, whenever you visit, access, register with or use the Site or any products or services provided by CGS Physician Services, LLC on or through the Site; and your continuing visit, access, registration with or use of any of the foregoing reaffirms your acceptance and agreement in each instance.
